2. Research the characteristics and origins of your dog's or cat's breed, as well as the advantages and disadvantages of owning or raising them. For example, an advantage may be a desirable, physical, or behavioural trait and a disadvantage may be a heritable disorder that is associated with the breed.
3. What criteria is important to consider when choosing a dog or cat, and why? Consider your lifestyle and preferences and how that would influence which traits in a dog or cat you might find desirable or undesirable.

### Activity 2.2 Signs of Normal and Abnormal Health

As animal caregivers, it is our duty to seek rapid diagnosis and treatment of abnormal behaviour, injury and disease. Calling a veterinarian is a first step towards seeking treatment for an animal showing signs of abnormal health.

**Instructions:** Do an Internet search and identify three veterinary clinics in your region that provide treatment for your selected animal. List these organizations, phone contact information, and website home address.

### Option A

Use the T-Chart below to create a description of physical and behavioural signs you would expect to see in a normal healthy animal and in an animal that is showing signs of abnormal health (i.e., illness, injury, disease). Your description can be in point or paragraph form.

#### **Option B**

Observe your animal for 30 minutes. Start by identifying the conditions under which you are completing your observation:

- Time of day
- Place observed
- Weather conditions.

Record your animal's condition or behaviours in the table below labeled with the three factors you choose to observe. Your observation of the animal should address three out of the following five factors (conditions / behaviours):

- Physical conditions (condition the hair coat)
- Sleeping habits (time of day, time spent standing or lying)
- Behaviour (facial expressions, vocalizations, social interactions)
- Locomotion (activity or weight shifting from one foot or side)
- Eating and drinking habits (time of day, amounts, time spent eating and drinking water).

## Activity 2.3 Vital Signs

**Instructions**: Answer the questions below in the boxes provided.

It is important to monitor vital signs, which indicate body functions and provide a "window" into the health of the animal. Vital signs include body temperature, heart rate (pulse) and breathing rate, or respiration. Regular monitoring of an animal's vital signs can help give an indication of what is "normal" for that animal.

Why is it important to evaluate the normal vital signs for an individual animal?			

Regular examination of body appearance, teeth, feet, nails is also an important aspect of animal care. In order to know what to look for, an animal owner should have a basic understanding of the animal's anatomy and physiology.

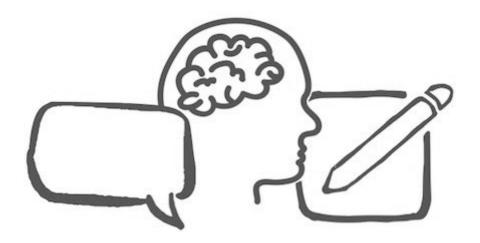
